

Can a licensee subcontract the installation and maintenance of EV charging infrastructure?

9.1 The Licensee may subcontract the installation or maintenance of the EV charging infrastructure but shall remain responsible for ensuring all terms of this Agreement are met. 9.2 The Licensee shall not assign this Agreement without the prior written consent of the Licensor, which shall not be unreasonably withheld, conditioned, or delayed.
