Consumers who subscribe to a community solar project receive net metering credits on their electric bill based on the size of their subscription and the output of the project.

Local Utility RebatesSubsidized LoansTax ExemptionsSolar Renewable Energy CertificatesNet MeteringSolar renewable energy certificates (SRECs) are another incentive that allows homeowners to earn a bit of extra income from running their systems. Simply put, users earn one SREC for every megawatt-hour, or 1,000 kilowatt hours, the system generates.
