What are the building regulations for solar panel installation?

There are certain building regulations you must abide by for solar panel installation. The solar panels must not put excess pressure on the property's roof. The installation would need to be completed by a certified installer. Electrical restrictions need to be considered too when completing the solar panel installation.

Are solar panels allowed on a property?

Certain conditions must be met for permitted development rights for solar panels which include: Panels must not protrude more than 200mm from the roof. This helps to protect the appearance of the building. The solar panels must not affect the structure of the roof or the appearance of the property.

Do I need a prior approval to install solar PV equipment?

Other than microgeneration solar thermal equipment or microgeneration solar PV equipment, if there is to be any other solar PV equipment installed on the roof of a building then the Prior Approval (56 days) of the Local Planning Authority is required.

Can a roof hold solar panels?

This clearly states that the roof must be examined to confirm it can hold solar panels. An installer is essential to check the weight of the solar panels that will be supported by the roof. The installer will assess the roof's structural integrity and will make sure it can handle the additional load.
